

RE-ENTRY PROGRAM

at Family Services of NW PA

Re-Entry is a support service offered by Family Services of NW PA that helps people who have been incarcerated make a successful transition to community life and reunite with family members.

Re-Entry is available to adults and their families who are preparing for, or who have already transitioned back into the community from incarceration.

Re-Entry Program Goals:

- Address the impact of incarceration on the individual and his or her family and reunify parents with their children.
- Reduce recidivism.
- Achieve or maintain family safety, stability, independence and unity.
- Strengthen communities by improving re-entry outcomes through broadened supports and community engagement.

Services May Include:

- Family Group Decision Making (FGDM) conference, which can include clients, families, children, providers or any combination of supports.
- Parenting Support Groups.
- Parent Education Classes.
- Skill Development, including Budgeting, Stress Management, Conflict Resolution, Daily Living, Anger Management, Parenting and Communication.
- Integrated Case Management.
- Goal planning to address housing, employment/training, wellness, legal, family education, and personal needs.
- Coordination with other providers.
- Assessment and Substance Use Screening with referrals as needed.


